### **3. General provisions**

The competition regulations (WB), the legal system (RO) and the anti-doping regulations (ADB) of the German Swimming Association (DSV) apply in the respectively valid version.

Members of clubs or starting communities that belong to a national federation affiliated to the DSV and hold the association rights, as well as swimmers whose national associations belong to the World Aquatics World Swimming Federation and whose starting and association rights they hold are eligible to participate. Participants must be at least 20 years old (cut-off date 31.12.2025).

By submitting its registrations, the registering club accepts these provisions.

All competitions are decisions. The setting of the runs takes place according to the registration times, regardless of gender and age group. The scoring is done separately according to gender and age group.

All competitions will be held according to the one-start rule according to §125 (6) WB.

The event was approved by the Rhein-Wupper swimming district (SB-RW) in the North Rhine-Westphalia Swimming Association (SV NRW).

### **4. Referee-court**

Referee panel is provided by the SB-RW in the key positions.

Clubs from NRW (LSB 17) are asked to provide one referee from three participants, two from six participants and three referees from 15 participants.

Additional referees from all clubs are welcome to be able to carry out the event.

Entry is requested by the registration deadline.

### **5. Entries**

Each participant has the opportunity to register for up to **five individual competitions**.

The registration of the individual competitions is only possible online on the website [www.duessel-cup.de](http://www.duessel-cup.de). **The registration deadline is March 30, 2025, 11:59 p.m.**

The teams will be registered informally by e-mail to [swim@duessel-cup.de](mailto:swim@duessel-cup.de) by the team captain of the respective club by **April 4, 2025**. Changes to the relay participants can still be made until **April 12, 2025, 10:00 a.m.**

With their registration, the swimmers assure that they have the right to start for the club, that the annual license required by § 22 (2) WB-AT has been paid and that they have proven their sports health by a medical certificate that is not older than one year on the day of the competition.

By submitting the registration, the clubs confirm that their registered active athletes are in possession of a valid sports ability certificate in accordance with WB AT § 8. Furthermore, the club assures that the active members of the registered team have the right to start for the club and that the annual licence prescribed by WB AT § 16 para. 2 (f) has been paid.

The entry fee must be paid by the registration deadline via the payment methods specified in the registration portal. Registrations will only take effect after receipt of the entry fee.

By submitting the registration, the clubs confirm that their registered active athletes are in possession of a valid sports ability certificate in accordance with WB AT § 8. Furthermore, the club

## **8. Awards**

The scoring is done separately according to gender and age group. The top three finishers per competition and age group in the individual and relay competitions will be awarded medals.

The medals will be handed over at the medal table in the swimming pool (pick-up); no medals will be forwarded.

**9. Age group division**

The age group is divided according to §152 WB (MS). The cut-off date for age determination is December 31 of the year in which the swimmer reaches the respective age.

The following age group classification applies to individual competitions:

The following age group classification applies to relay competitions:

For the age group division in relay competitions, the age is summarized in whole years of life of the relay members. The age groups of the individual swimmers are not to be taken into account here.

German age group records in relay competitions may not be recognized if a swimmer in the age group 20 was involved.

In the mixed relays, 2 women and 2 men start in any order.

## **10. Inclusiveness**

Participants with an identity outside of "male" and "female" can participate in the swimming tournament as "diverse" (d). However, the rules of the World Aquatics and the DSV do not allow a competition with reporting of the performances to the federations. These participants (d) will start in their own competition outside the official association ranking, alternatively the gender female/male can be decided after consultation with the organizer, so that a registration of the performances is possible.

## **11. Privacy policy**

By registering, the participant agrees to the privacy policy of the Düssel-Cup GbR, which can be accessed under <https://duessel-cup.de/datenschutz/>.

By participating in the competition, the participant also agrees to the electronic storage, processing and disclosure of competition-relevant personal data, stating name, club name, age, class, competition name, start number and start time. This processing is carried out in accordance with Article 6 (1) (b) GDPR. By participating in the competition, you also consent to the processing and publication of the start and result lists as well as, if necessary, photos of the competition and the award ceremony in notices, on the Internet, in social media and in other publications of the SB-RW. Participants can object to the storage, processing and use of their personal data and request deletion. The consequences result from the competition regulations of the DSV. The results lists that have already been published will not be changed in the event of an objection to publication, they will remain in place.
