AGB OUTREACH-PROGRAMM

- The Outreach Program is a support program of the Düssel-Cup. It is aimed at potential participants from the LGBTIQ community in other countries in which being open about one's self-assigned gender identity and/or sexual orientation is not legal, not possible or involves considerable discrimination from the state and society.
- 2. The minimum award is free participation in one sport. This includes an invitation to a reception, the party and, if offered, the brunch. Further support such as free accommodation and a financial contribution must be explicitly requested. This does not exclude participants from potential further benefits in the outreach program.
- 3. The budget is limited, therefore the application must be assessed with regard to the following criteria:
 - a. As many countries and regions as possible should be considered.
 - b. A balance of all (gender) identities should be considered.
 - c. As many sports as possible shall be considered.
 - d. In the case of team sports, the team members shall also be assessed together.
 - e. We will give preference to many people with few financial resources over a few people with many resources. Of course we will take into account justified exceptions to this rule.
- 4. Decisions are made by the outreach team within the overall budget.
- 5. Local hosts will be sought if free accommodation is requested. If the demand is higher than the supply of hosts, the outreach team reserves the right to assign you a suitable place to stay in hostels, youth hostels or hotels. This may be a shared room. In this case, appropriate requests regarding your gender identity will be considered.
- 6. There is no legal entitlement to participate in the support program or to the amount of financial aid. Financial support of further costs beyond those already applied for is not possible.

DATA PROTECTION

To enable us to process your application and to be able to contact you, we process the data provided in this form on the legal basis of the DSGVO. Incomplete personal data can lead to the rejection of your application.

Your data will be stored with us only as long as we need it to process your application. Afterwards we store your name, address and date of birth within the legal retention periods.

At any time, you have the right to obtain information on the personal data concerning you that we process and to have this data corrected or deleted. Furthermore, you have the right to object to the further processing of your personal data at any time. You can send your objection informally in writing to the office or, if applicable, to the data protection officer.

You have the right to receive from us, upon request, the personal data we have stored about you in a structured, common and machine-readable format or that we transfer your data to another responsible party.

If you believe that your data has been used unlawfully, you have the right to complain to the competent supervisory authority under Art. 77 DSGVO: State Commissioner for Data Protection and Freedom of Information North Rhine-Westphalia: ldi.nrw.de
